- ➤ Transparency is practiced after the evaluation of answer papers in which students are given Xerox copies of answer scripts for perusal and subsequent claim for revaluation
- ➤ Multiple Choice questions are given for 10 Marks for U.G. students.
- Results are published within 20 days after the examinations
- After the final semester examinations, supplementary exams are conducted in July every year to facilitate students to go for higher studies or jobs. A student who has failed in exactly one paper is permitted to write that paper.

### 6.3.2 Teaching and Learning

The Central Library has setup INFLIBNET, ELNET facilities through which large number of e-resources including journals can be accessed. The Digital Knowledge Repository of the University has been established for the purpose of comprehensive access to scholarly digital contents (journals, e-books, articles, electronic theses and dissertations, video & audio resources) to the students, faculty and staffs.

Academic and Administrative Audit is conducted once in a year.
